# EDGE Report 2018

The Edge is a multidisciplinary built environment think tank with members drawn from across the built environment professions and beyond. It held its first debate on June 18<sup>th</sup> 1996.

#### Introduction

2018 was a busy year for the Edge even if it lacked a single focused activity and it has been operating on a number of different initiatives trying to identify a purposeful future for the construction and property industries in a time of intense change, challenge and uncertainty.

### Edge activities - summary

#### <u>Partners</u>

In 2018 the Institute of Environmental Management and Assessment (IEMA) joined the Edge as a partner organisation.

Discussions are also underway with the Chartered Institute of Environmental Health (CIEH) and the Chartered Institution of Highways and Transportation (CIHT).

The Edge has become a Strategic Partner to Futurebuild

## **Engagement**

Over the year the Edge has had meetings with CIC, RIBA, Each Home Counts, CIBSE, ICE, LETI, IRG, UCL, IEMA, University of Reading, University of Cambridge, RAEng

## Institutions

The Edge continues to work on a number of issues that emerged from Collaboration for Change, the Edge Commission Report on the Future of Professionalism.

Code of Conduct: during 2018 the Edge has consulted a range of Professional Institutions (PIs) several of which have shown interest in using the draft model code (see www.edgedebate.com/?page\_id=3185) as a resource for rewriting or updating their own codes. The RIBA in particular has formally adopted the Edge's proposition that construction professionals owe duties of care to the wider world, society and the end user, those commissioning services, those in the workplace, the profession and towards oneself (RIBA Council Decision – September 2018).

The RIBA has also formally adopted a version of the Edge's 'professional compact' (see below), which sits alongside and supports the code, to describe "the key factors of a successful professional relationship" (RIBA Council Decision – December 2018).

The Edge proposes to finalise its proposals for a joint code + professional compact for publication in 2019.

Institutions - continued ...

- The Edge has also been in discussion with the PIs on its 'Best Practice Reporting Standard'. The Standard encourages the PIs to include consistent year on year data reporting in their annual reports; including information on membership, staffing, discipline, education and outreach. The Standard aims to align with requirements under the Equality Act 2010 and the Royal Academy of Engineering's Diversity and Inclusion Benchmark.

The Edge hopes to publish its proposal for the Reporting Standard along with evaluations of past and current institutional reporting in 2019.

 In 2018 Edge members Stephen Hill, Simon Foxell, Robin Nicholson and Elanor Warwick contributed to the work of the RIBA Ethics and Sustainable Development Commission, which reported its findings in December 2018 (see www.architecture.com/knowledge-and-resources/resources-landing-page/ribasethics-and-sustainable-development-commission-final-report).

The Edge sent a letter of support to the Commission in October 2018

## **Consultations**

In 2018 the Edge, in collaboration with CIBSE and other organisations, responded to a number of significant consultations:

- The London Plan: providing a detailed, clause-by-clause analysis of the Plan with proposals for amending and improving its provisions. (February 2018 – with follow up)
- National Planning Policy Framework: Recommendations to make the Framework more effective in a number of areas including; quality and sustainability, environmental net gains and green infrastructure with a call for ensuring the NPPF will deliver against the Sustainable Development Goals (SDGs) and the 25 Year Environment Plan (25YEP) (May 2018).
- DEFRA Consultation on Environmental Principles and Governance: Following a public debate (Edge Debate 83 – see below) the Edge submitted its response and recommendations for environmental governance to be developed at a UK level in support of clear principles (including non-regression, protection and conservation) and for effective accountability and enforcement. (August 2018)

## Edge Debates

## Thinking

The Edge is a thinking organisation and provides a forum for a wide range of industry expertise to come together to address current issues, policy development and emerging ideas; to reconsider previous experience and bring extensive practical knowledge to bear on present problems.

The Edge's focus is the built environment and the professional bodies that work with it; but it has the freedom to think widely and to propose initiatives and policy ideas that address the big picture. It will continue to use its institutional freedom to challenge, to provoke and to influence. Importantly, the Edge's connections and thinking capacity are available to other built environment bodies to help them develop thinking, share ideas, test propositions. The Edge can act as a sounding board for an industry that needs to converse more across its internal and external boundaries.

## **Future Activities**

In 2019 the Edge intends to keep up its regular activities and debate programme. It also plans to launch a new Commission of Inquiry to tackle the subject of Professional Education for the built environment. This will build on the success of the Inquiry on the Future of Professionalism and the subsequent report, *Collaboration for Change*, written by the Inquiry Chair, Paul Morrell. The Edge is currently recruiting a Chair for the Commission together with a panel and looks forward to announcing these in the first half of 2019.

## In Memoriam

In 1995 the former Chair of Ove Arup and Partners, Jack Zunz (1923 – 2018), challenged the RIBA and the ICE to find a way of working better together. The result was the Edge, which, with support from The Ove Arup Foundation, held its first debate in 1996.

In 2018 the Edge also lost one of it earliest supporters, Michael Dickson (1944-2018), a founding partner of BuroHappold Engineering.

#### Linkages

The Edge works at the intersection of the construction industry professions, research bodies and policy-making groups inside and out of government. Its members maintain regular contact with professional and academic bodies, technical and campaigning organisations and central and local government departments. Members of the Edge also teach and lecture widely, both in the UK and abroad as well as being active professionally in the design and delivery of significant projects across the world



- train and help develop the abilities of other members of both their profession and society;
- measure, feed back and share relevant information and insights gained from their work in order to develop and improve knowledge and skill across the disciplines.

## In exchange for:

- the trust of those commissioning services;
- recognition of their independence and right to self-direction;
- the grant of respect and status;
- a degree of exclusivity over the provision of socially important services;
- fair payment for their work.
